

Fire Chief's Report

In 2014 the El Cerrito-Kensington Fire Department's Fire Prevention Division continued to have a very busy and successful year. The major programs the Fire Prevention Division is involved with include: Mercantile Fire Safety Inspections, New Building Construction which includes plan reviews and field inspections, Public Education and our Weed Abatement Program. These four programs keep the Prevention Division extremely busy throughout the year and provide us with our greatest challenges and rewards.

Fire Safety Inspections

El Cerrito-Kensington has more than 500 businesses that are inspected annually by on-duty engine companies. There are typically six types of inspections our engine companies conduct. They are: General Fire Safety Inspections, Educational Facilities, Fire Sprinkler Inspections, Fire Alarm Inspections, Hazardous Occupancy Inspections and Commercial Cooking Fire Suppression (Hood & Duct) Inspections. Many of the businesses that are inspected by engine companies receive multiple inspections concurrently (e.g. Fire Safety, Fire Sprinkler and some require all six inspection types to be conducted). Of these 500 businesses, we had a 95% completion rate. The businesses that do not comply are forwarded to the Fire Prevention Officer to ensure Fire Code compliance is met. The result of our comprehensive Fire Safety Inspection Program is one of the lowest fire losses in commercial occupancies in the state.

New Building Construction Inspections

New building construction includes plan review, on site inspections and final inspections. In 2014, we completed 74 plan reviews and more than 30 construction site inspections. Construction site inspections conducted by the Prevention Division mainly focus on Life Safety Systems. The majority of these site inspections include fire sprinkler, fire alarm system installation and acceptance, water supply and hydrant spacing, commercial cooking facility fire suppression systems, emergency exiting and lighting.

Public Education

Our infant car seat installation program continues to be a great success, and continues to expand. This year there were 49 infant and child car seats installed for Kensington and El Cerrito residents. Our Fire Department car seat installers also worked with John Muir Hospital hosting a car seat installation workshop and have participated in other car seat installation workshops throughout the region installing car seats with John Muir Hospital staff. In addition to installing the car seats, our fire department installers train the new parents in how to correctly and safely install or transfer their car seats between their vehicles.

The Fire Safety Trailer continues to be a great success in public education. We have achieved this by being extremely active in seeking opportunities to educate the public in fire safety. The main avenues we reach the public is through fire station tours, going to public and private schools and other public events such as the Tri-City Safety Day, Fourth of July and the Halloween festival.

In addition, we conducted six CPR/First Aid classes for the public that has drawn 100 students. The citizens of Kensington and El Cerrito are excited and eager to seize every opportunity to learn about fire safety.

Weed Abatement Program

Our Weed Abatement program remains our most challenging and time consuming program, consuming hundreds of personnel hours. The program consists of inspecting every property within El Cerrito and Kensington, identifying fire hazards and having those fire hazards removed or brought into acceptable levels. After every property is inspected, a letter of non-compliance is sent to those properties and property owners that do not comply with the City's "Vegetation Management Standards". This year we sent out more than 300 notices of non-compliance and had all but two of the properties brought into compliance voluntarily. Kensington had 100% compliance. This was achieved through the hard diligent work of the Fire Prevention Department personnel, making hundreds of phone calls and numerous site visits educating property owners of the risk and standards they were to maintain.


The Fire Plug

INSIDE THIS ISSUE:

The Community of Kensington and the Wildland Urban Interface

California is experiencing fire season year-round due to the extreme drought. This requires everyone to be on heightened alert for any threat of wildland fire.

If you live next to the Wildland Urban Interface (WUI) you must prepare your property and surrounding vegetation to provide fire-fighters the defensible space that they need to protect your home. The buffer zone you create helps keep the fire away from your home and reduces the risk from flying embers.



A home within one mile of a wildland fire can be threatened by wind driven embers, even if it is located outside the WUI and is far from the front of the fire. Fire resistive construction materials and the quality of the defensible space surrounding it are what give a home the best chance to survive a wildland fire.

You must be prepared well before the fire occurs by checking and maintaining the following:

Roofs

Clean leaves, limbs and pine needles from the valleys, rain gutters and end of barrel tiles on a regular basis.

Eaves

Embers can gather under the open eaves and ignite exposed wood or debris. Maintaining clean eaves or boxed-in eaves provides better protection.

Vents

Make sure all eaves and gable vents have screens to prevent wind-driven embers from entering the attic area.

Balconies/Decks

Use heavy timber or noncombustible construction material for decks. Enclose the underside of balconies and decks with a fireresistive material to prevent any wind-driven from entering. \

On Saturday, May 9, 2015, you can bring your unused/unwanted medications to the Kensington fire station for safe disposal. We will be accepting medications on that day between the hours of 10:00 a.m. to 2:00 p.m. No questions are asked.

We are no longer able to accept all medications. Narcotics (or controlled substances) will not be accepted and will need to be disposed of through the West County Household Hazardous Waste Program. please contact KFPD at (510) 215-4450. We will accept all other medications including liq-

uids and sharps. We will not be accepting any

household hazardous waste.

Please help keep toxins out of our water systems (do not flush unwanted medicines



down the toilet!) and unused medications out of the hands of youths.

Annual Vegetation Management Inspections

The community of Kensington is in a "Very High Fire Hazard Severity Zone".

Each year, during the spring months, Fire District personnel inspect every property in Kensington. These inspections are conducted via "driveby". Inspections can also be complaint driven (if we cannot see the alleged hazard from the sidewalk). The Fire Prevention Officer will be checking properties to ensure that they comply with the Kensington Vegetation Management Standards that help keep Kensington a safe community.

The properties that do not comply will receive written notification from the Fire Prevention Officer. Reinspection of those properties in violation will then take place, followed by a KFPD Board of Directors hearing if the property is still not abated. This notification process is in place to remind homeowners that it is your responsibility to protect your home and the community from the devastating effects of wildfire. In past years, voluntary compliance from the residents has been outstanding and we look forward to full cooperation this year.

If you need guidance in resolving a fire hazard on your property or you would like a copy of our

Defensible Space brochure, please call the Fire Prevention Officer at (510) 215-4457 for assistance. We are happy to help!

Remember that you make the greatest difference in keeping your home, neighborhood and community more fire safe!

Vegetation management tips:

Trim tall trees up 10 feet from the ground. Remove dead and dying branches, loose and papery bark, and fallen branches.

Cut trees 10 feet back from chimney openings.

Install a spark arrestor on all chimneys and stovepipes.

Keep roof and decks free of leaves, needles, twigs or other dead vegetation.

Fire resistive plants and shrubs are recommended.

All abatement must be maintained throughout fire season.

Child Car Seat Installation

Drivers are responsible for proper installation of child safety seats. Properly installed child safety seats are critical for the survival of an infant or toddler involved in a car crash.

Since the correct installation of a child restraint system can be a challenge, KFPD offers free child safety seat inspections for Kensington residents only. Two of our firefighters are trained Child Safety Seat Technicians.

Residents who have installation problems or are unsure if their child safety seat is properly installed can contact KFPD for a free inspection by calling (510) 215-4450 or emailing: fire@kensingtonfire.org. It typically takes approximately one week for an appointment after we are contacted.

Please arrive at your appointment with the car seat installed and if possible, bring your car seat's instructions. Having the child present is best but not necessary.

The Fire Department is a member of the Child Seat Safety Coalition sponsored by John Muir Health. Throughout

the year, the Coalition sponsors child safety seat checkpoint events at various locations.

Along with Mr. Wandry's family and friends, CCWD's Board and staff are deeply saddened by his passing and he will be missed.


Legislative Leaders Honor CCWD Director Bette Boatmun


Central San produces approximately 600 million gallons of recycled water each year.

DSRSD Chemist Named Lab Person of the Year by Bay Area CWEA

Connie Sanchez, a chemist with Dublin San Ramon Services District (DSRSD), has been honored as the 2014 Lab Person of the Year by the San Francisco Bay Section of the California Water Environment Association (CWEA), the leading training and certification organization in California for the wastewater industry.

"I congratulate Ms. Sanchez for her skills, diligence, and attention to detail in the tests she conducts every day that help keep our water clean and protect public health," says DSRSD Board President Ed Duarte. Laboratory Supervisor Raj Gumber nominated Connie Sanchez for Lab Person of the Year because of her consistent achievements as a chemist. Gumber won the same award 17 years ago as a DSRSD chemist. In March 2014, Connie Sanchez earned CWEA's highest certification for laboratory analysts, Grade IV, and has been a CWEA member since 1999.

The DSRSD environmental laboratory staff runs approximately 10,000 tests each year on samples of wastewater, drinking water, recycled water, groundwater, and biosolids. The District uses test

results to report to regulatory agencies at required intervals, as well as to manage wastewater treatment processes and monitor the quality of potable and recycled water distributed to customers.

Sanchez is responsible for analyzing the amounts of potentially toxic substances, such as metals and volatile organic chemicals, as well as conducting many other chemical and biological tests. She administers the laboratory's database that tracks and compiles all test results. The five-person laboratory staff includes a supervisor, two chemists, and two technicians.



CWEA awards acknowledge outstanding achievement in more than 20 categories, honoring exceptional California water environment professionals, wastewater collection systems, and treatment plants. As a winner at the section level, Sanchez will compete for the statewide CWEA Laboratory Person of the Year award, which will be announced in April.

DSRSD Recycled One Billion Gallons of Water In 2014!

Dublin San Ramon Services District (DSRSD) Recycled water eased the impact of drought in the Tri-Valley this past year, keeping valuable landscaping alive and construction projects going while saving more than a billion gallons of drinking water.

Dublin, Pleasanton, and southern San Ramon produce 10 million gallons of wastewater every day that must be handled efficiently and safely to protect public health. Increasingly, wastewater treatment is a resource recovery operation that creates recycled water for irrigation and construction and biofuel for generating electricity. DSRSD partners with East Bay Municipal Utility District and the City of Pleasanton in producing recycled water, which has grown to more than 20 percent of DSRSD's total water sales.



DSRSD Hires New Managers for Engineering and Administration

Dublin San Ramon Services District (DSRSD) has hired two senior managers to oversee engineering and administration, filling openings created when three members of its management team retired in 2013.

Rain Brings New Risk of Mosquitoes

Catching rainwater now to use on plants later is a great idea. Giving mosquitoes new places to lay their eggs is not. Before you put a bucket or container out to catch the plentiful rain, think about this: mosquitoes need just two tablespoons of water in which to lay up to 400 eggs. And late fall and winter is the time of year when some mosquitoes thrive. Seven of the 23 different types of mosquitoes in Contra Costa County are present in fall and two make their appearance in winter. Indeed, mosquitoes are still around.

To prevent mosquitoes during the rainy season, frequently check your property. Make sure you don't have tools, toys or containers collecting rainwater. Clean your gutters to make sure leaves or branches aren't stopping water from draining completely. And if you have a swimming pool you are not maintaining over the winter, visit Contra Costa Mosquito & Vector Control District to get free mosquito-eating fish. Neglected swimming pools produce thousands of mosquitoes — the type that can transmit West Nile virus.

Saving water is a great idea, if it's done carefully. Many garden stores sell rain barrels designed to deny mosquitoes access.

Richard was appointed as the Oakley representative for the Contra Costa Mosquito & Vector Control District, and was a trustee for about 11 years. He was on the board of Directors for the Diablo Water District until his passing. He felt honored to serve Oakley in those capacities.

Richard provided insight and support as the district improved its water supply reliability through the use of local ground water. He provided invaluable input and direction for the district's public communication program, new office building, and annual budgets. Richard represented the district at East County Water Management meetings.

His personality and his passion for the district earned the admiration and respect of the directors and staff of Diablo Water District.


